Chronic	Substance accumulation, in the human body, may occur and may cause some concern following repeated or long-term occupational exposure. Repeated minor exposure to acetic acid by mouth can cause blackening of the skin and teeth, erosion of the teeth, vomiting, diarrhea and nausea. Repeated minor vapour exposure may cause chronic inflammation of the airways and bronchitis. Results from testing are mixed, with one report indicating only slight irritation to the airways, stomach and skin, while another reported inflammation of the conjunctiva, bronchi, pharynx and erosion of teeth. Exposure to higher levels caused blackening and hyperkeratosis of the skin and hands. Heartburn and constipation have also been reported with prolonged exposures.

ACETIC ACID GLACIAL

Asthma-like symptoms may continue for months or even years after exposure to the material ends. This may be due to a non-allergic condition known as reactive airways dysfunction syndrome (RADS) which can occur after exposure to high levels of highly irritating compound. Main criteria for diagnosing RADS include the absence of previous airways disease in a non-atopic individual, with sudden onset of persistent asthma-like symptoms within minutes to hours of a documented exposure to the irritant. Other criteria for diagnosis of RADS include a reversible airflow pattern on lung function tests, moderate to severe bronchial hyperreactivity on methacholine challenge testing, and the lack of minimal lymphocytic inflammation, without eosinophilia. RADS (or asthma) following an irritating inhalation is an infrequent disorder with rates related to the concentration of and duration of exposure to the irritating substance. On the other hand, industrial bronchitis is a disorder that occurs as a result of exposure due to high concentrations of irritating substance (often particles) and is completely reversible after exposure ceases.

The disorder is characterized by difficulty breathing, cough and mucus production.

For acid mists, aerosols, vapours

Test results suggest that eukaryotic cells are susceptible to genetic damage when the pH falls to about 6.5. Cells from the respiratory tract have not been examined in this respect. Mucous secretion may protect the cells of the airway from direct exposure to inhaled acidic mists (which also protects the stomach lining from the hydrochloric acid secreted there). The material may produce severe irritation to the eye causing pronounced inflammation. Repeated or prolonged exposure to irritants may produce conjunctivitis.

The material may cause severe skin irritation after prolonged or repeated exposure and may produce on contact skin redness, swelling, the production of vesicles, scaling and thickening of the skin. Repeated exposures may produce severe ulceration. Prolonged or repeated exposure to acetic acid may produce irritation and/ or corrosion at the site of contact as well as systemic toxicity. Prolonged inhalation exposure results in muscle imbalance, increase in blood cholinesterase activity, decrease in albumin and decreased growth but no reproductive or foetal toxicity, according to animal testing.
